Dispatch advised a juvenile male was observed entering the above listed hotel room with an adult male and further advised the juvenile's father, _____ was on scene.

Contact was made with _____ who advised his juvenile son, _____ (V-1), was observed entering the hotel room with an adult male subject. _____ advised _____ girlfriend, _____ (W-1), witnessed this and called him in reference _____ she observed.

_____ advised he had not reported _____ a runaway at this time, but advised _____ has a history of soliciting himself on Craigslist for sexual conduct. _____ also advised _____ has a history of drug abuse and he was uncertain if _____ was in the hotel room for illegal narcotics or for sexual activity.

Off. Minard, Off. Shahan and I approached the hotel room and I could smell a strong odor of raw marijuana emitting from the hotel room. I knocked on the door twice, receiving no answer and proceeded to check the back of the hotel to see if there was window. I located no window and returned to the front where Off. Minard was conversing with someone through the door.

The subject was advised to open the door and he inquired as to why we were there. The male subject was advised he needed to open the door due to our knowledge of a juvenile being inside the hotel room and the odor of marijuana emitting from the room. The male subject advised there was no one other than him inside the room and he was instructed to open the door or we would enter the room with the master key provided by the management. The door opened with the juvenile male, _____ exiting the room with the adult male standing behind the door.

The adult male, later identified as _____ (S-1), was instructed to step out from behind the door and show his hands and I instructed _____ to sit down on the sidewalk.

I asked _____ why he was there in the hotel room and he advised he was just there to hang out with his friend. I asked him what his friend's name was and he advised his name was Brian, but did not provide a last name. I informed him I could smell the odor of marijuana coming from the room and asked who brought the marijuana. _____ advised he _____ brought marijuana and he (pointing to the hotel room towards _____) matched it. I asked _____ if I could look through his backpack and he advised I could. I could smell the odor of marijuana coming from the backpack, but only observed a bottle of lotion inside the backpack.

I asked _____ how he got to the hotel room and _____ advised he (motioning his head towards the hotel room towards _____) picked him up.

I asked _____ how long he has known him _____ and _____ advised he has known him for approximately one year and advised he _____ used to sell weed to him.

I contacted _____ inside the hotel room and inquired how long he has known _____ and he advised they have texted each other for over a year. I asked _____ what they were doing in the hotel room and

he advised just hanging out. I asked about the marijuana and he advised, brought it. I asked if he had any and he advised he did not and was the only one who smoked it. I asked how arrived at the hotel room and advised he picked up from his residence. I asked what name knew him by and he advised his name I asked what other name due to advising a different name and advised he has a screen name of "Jamie".

had a backpack lying on the ground and I asked if I could look inside it and he advised I could. I did not locate any marijuana inside the backpack, but did observe an open box of condoms.

I left the hotel room and escorted to vehicle and I provided with backpack and a Kindle Fire tablet was in possession of. When I provided the Kindle to overheard advised he could check the Kindle for conversations had on Kick and Instagram.

advised he would prosecute on behalf of for any proven crimes. left the area with and I then contacted

advised had informed her earlier in the evening he was going to get paid tonight. advised does not have a job and waited down the street from residence in fear was still involved in illegal narcotics. she observed exit his residence and get into the which is owned by, and proceed to the hotel. advised she observed and exit the vehicle and enter the hotel room together at which time she immediately called.

advised left the Kindle with her and she discovered a conversation from this evening between and a screen name of Jamie Tilley which at 0013 hours stated "I'm here". advised that was about the same time exited the residence and got into the vehicle.

showed me the beginning of the conversation which was started by asking "Is there anything I can help you do some cash", followed by "Jamie Tilley" asking "How much you needing?". responded by stating "I need money for spring break" and "Jamie Tilley" responding "I don't really have any legitimate things I need help with right now. Would you be interested in "sexual" stuff?".

advised I could take the Kindle if I wanted and I asked to wait for just a few. I contacted by phone and asked if I could take possession of the Kindle and log it into property as evidence. advised I could take possession of the Kindle in hopes of prosecution. I made contact with and took possession of the Kindle and she advised there is no password lock on it, I would just need to swipe the lock button on the screen.
